

**SINGLE-USER LICENZE AND COPYRIGHT**

**for the software 'GeoProject (CAD for Pocket PC) and attachment'**

This agreement is between the end user and FLOORNATURE.COM, for the software contained in the enclosed mini CDROM called " GeoProject and attachment"

**(1) User rights.**

With this agreement, FLOORNATURE.COM grants the end user the right to use a copy of the specific release of the software in the enclosed mini CDROM on any individual Pda. If the end user has multiple-user right, he may use the number of mini CDROM copies for which he has received authorisation. The software on the enclosed mini CDROM is regarded as being used in a Pda when it is loaded into the volatile memory (ROM, RAM) or installed in a permanent memory (hard-disk, memory card, etc.) on Pda.

**(2) Copyright.**
